Application: Application submissions must be complete. Any application received without one or more of the requirements will not be submitted to the selection committee for evaluation nor considered for the scholarship.

Eligibility: Any trades person studying any of the following, interested in studying the following, or interested in obtaining necessary OSHA classes: Occupational Safety & Environmental Health; Environmental Protection & Safety Management; Civil & Construction Engineering Technology/ Public Health; Environmental Science; Safety Management; Public Safety Management, or Safety Science, CSP or CHST Certifications.

Award: Two \$1,250.00 award for the 2017-2018 MACSC Fiscal Year (September 1 –August 31), written directly to the individual winners to be used to help defray the cost of credits, books, and other costs incurred while in pursuit of a degree or certification.

Criteria: To be eligible for consideration, applications must include the following:

- A fully completed and signed application form.
- An original essay by the applicant describing his or her personal circumstances and how the applicant intends to encourage awareness and foster change within the Construction Industry specifically in the area of safety. Essays should be typed, no more than two (2) pages, using a 12-point font, double-spacing and 1" margins.
- One letter of recommendation as outlined in Part III.
- A transcript (unofficial transcripts are acceptable) from the last education institution attended.

Applicant must reside or attend a school, college, or university in one of the following regions of Delaware Valley, including areas centered in Philadelphia, Pennsylvania, Wilmington Delaware, New Jersey, Delaware Maryland (PA-NJ-DE-MD).

Deadline: Completed applications must be postmarked no later than **Tuesday, August 21, 2018.**

Notification: All applicants will be notified of the selection committee's decision no later than **September 10, 2018**. The recipient(s) of the award will be asked to attend, as our guest, the annual awards luncheon that is held on **November 2018 (date tbd)**.

Administration: The Mid-Atlantic Construction Safety Council Scholarship is administered by a sub-committee of the Council who has final and binding discretion to decide all questions regarding the awarding of the MACSC Scholarship, its administration, and its terms.

Limitation: As the Mid-Atlantic Construction Safety Council is an incorporated non-profit association and does not directly employ any person, all Council members and their immediate family are eligible for the award, assuming all other eligibility criteria is met. Past recipients are eligible to apply for the award, given they still meet all requirements and submit a new and complete application.

Ownership: All submitted applications and essays become the property of the Mid-Atlantic Construction Safety Council and may be published by the Mid-Atlantic Construction Safety Council. Successful essays may be published by the Mid-Atlantic Construction Safety Council and may be, along with information about the winner, shared widely through our website, news releases, and other media. Winners must provide a photo of themselves for MACSC's use in public communications.

Do not hold transcripts until the end of the semester, as applications submitted without a transcript will not be submitted to the selection committee for evaluation nor considered for the scholarship.
