### **Essential Functions**

Under the direction of the Safety Director, the EHS Training Manager is responsible for developing, implementing, and managing safety training programs within JD Eckman Inc. This role ensures compliance with relevant safety regulations, promotes a culture of safety and facilitates training programs to enhance employee skills and knowledge. The EHS training manager collaborates with various departments to create a safe working environment and improve overall operational efficiency.

## **Duties and responsibilities**

## **Training Program Development**

- Develop, implement, and conduct JD Eckman's training program to comply with OSHA, JD Eckman policies, and contractually required training.
- Coordinate with external training providers when necessary.
- Assess training needs and develop comprehensive training programs for employees at all levels.
- Collaborate with department heads to identify specific skill requirements and implement targeted training sessions.
- Create training materials, presentations, and documentation to support various training initiatives.
- Manage the companies Learning Management System(LMS) to provide virtual training through multiple vendors and schedule various training events.
- Evaluate the effectiveness of the training programs and make continuous improvements.
- Keep all records of training documents, including certifications and qualifications.

## Safety Compliance

 Conduct regular safety audits, risk assessments and inspections to identify and address potential hazards.

## **Incident Investigation and Reporting**

- Lead investigations into workplace incidents, accidents, or near misses to determine root causes.
- Compile incident reports, analyze data, and recommend corrective actions to prevent future occurrences.

- Bachelor's degree in a safety related discipline.
- 5+ years of experience in a safety role within a construction environment, preferably in heavy highway.
- Proficient knowledge of OSHA and DOT laws
- Ability to interpret a variety of instructions in written, oral, diagram or schedule form
- Effective communication and interpersonal skills necessary to work and communicate effectively with people at all levels of the company
- High level of proficiency in Microsoft Office applications (Word and Excel) is required
- Ability to solve practical problems and deal with a variety of concrete variables in situations where only limited standardization exists
- Ability to work independently
- Must be proactive and solution oriented
- Ability to work with a high degree of confidentiality is required

# **Working conditions**

This position may be subject to more stringent drug testing and compliance policies associated with our status as a Federal Contractor.
